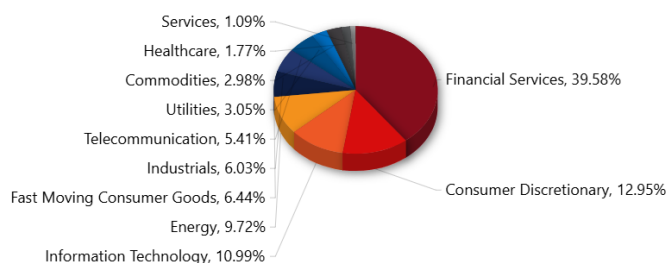

However, the number of companies in the index remains fixed at 30. • Stocks must have a listing history of at least six months at BSE and must have a derivative contract. • The stock must have traded on every trading day at BSE during the six-month reference period.
